- 5. Low-member clubs Be diligent. Reach out and support. Be patient, enthusiastic. Promote the benefits of Toastmasters.
- 6. Reinstating Suspended Clubs Toastmasters International has a new incentive for reinstating clubs that were recently closed or suspended between March 2023 and October 2023. The incentive is good through June 30, 2024. Clubs eligible for this incentive are: Nampa Toastmasters, Rise and Shine, Statehouse Toastmasters, SLC Amex Toastmasters, Speak Intuit, Toastmasters @Progrexion, Klasically Speaking. Clubs taking advantage of this incentive can return to good standing without having to charter as a new club.
- 7. Corporate Clubs: Easy to build up and quick to lose. Resistance against weekend officer training. How to support corporate clubs: Know corporate structure, define purpose, get an advocate or champion in the corporation to promote Toastmasters, advocate the benefits, promote the value in leadership and feedback opportunities.
